I. Call Meeting to Order: Chairman SHaron Clark called the meeting to order at 6:07 P.M.

III. Approval of Agenda: Betty M. Wassily moved to approve the agenda as is. Seconded by Aurora George. Motion Carried.

IV. October 13th 2008 Minutes: Betty M. Wassily moved to approve the minutes as is. Seconded by Aurora George. Motion Carried.

V. Guest Present: Present were Doug Bushey, Alyssa Bushey, Samantha Clark, Margaret Gardiner, and Patti Quinn Teacher Mentor.

VI. Public Comment:

1. Harry Egbert-Guns on School Property Diane Tennyson said that Tom was unable to attend because his son is getting sick, but he told me what to say. Tom told Diane that Logan was shooting a gun on school property because Pauline Wassily the school cook heard the shot in the kitchen. Doug said later on that day he heard about the incident and told all staff that if we see or hear of anything that endangers the kids that we are to let him know asap so that he may conduct the proper investigation. Betty M. Wassily abstained, as did Aurora George, Diane Tennyson was in favor as was Sharon Clark. Sharon told Doug to ask if she will be available and if she is still willing to work at the school. Doug told the council that while she was in Anchorage with her mother she had called and on Monday as well. Sharon asked Doug if the position was closed and the answer was open until filled. Sharon told Doug to post the job description until the 15th so that everybody knows.
4. Secretarial Position: Margaret Gardiner had turned her resignation in and it was accepted and faxed to the District Office. So, we will have two positions opened at the school now.

Wassily made a motion to recommend Doug and Rochelle Bushey for teacher of the month. Seconded by Aurora George. Motion Carried.** Margaret asked if she should type up a paper for Sharon to sign. Sharon said that she would type up and send to the district office.

Public Comment: Betty said that it was brought to her attention that the kids would like to stay inside for recess as it was too cold outside. Doug said the reason he sent the kids outside was because the CSC voted for students to play outside when the temperature is 10 degrees above. Doug said the temp in the office said it was 18 degrees above and there was also voting going on in the ball room. Margaret said that only one kid wanted to go outside, and the temp on the trailer outside said 11 degrees above and that if the kids stay inside they play the Basket Ball Game bump, and play on the DDR and that they get more exercise playing those games. Sharon asked what they play outside. Margaret let her know that the younger kids play and the older girls usually stand by me and we talk. Sharon said that she may be old school, but it seems the Administrator should make the decisions. Sharon said to use the internet for the temperature as it is really accurate. **Betty M. Wassily made a motion to go with the majority of the kids's decision whether the recess will be inside or outside if the temp is between 10 degrees and 25 degrees above. Seconded by Anthony Clark. Motion Carried.**
