Overview

In support of strengthening student academic achievement, **Southwest Region School District** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by Section 1116(b)(1) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended. Joint Development

There will be an annual meeting for the public in which Title I programs will be reviewed and discussed including the parent and family engagement plan.
