Overview

In support of strengthening student academic achievement, **Southwest Region School District** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by Section 1116(b)(1) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended. The **Southwest Region School District** agrees to implement the following requirements as outlined in Section 1116 of the ESEA, as amended:

Joint Development

Togiak School will take the following actions to involve parents and family members in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I, Part A programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

There will be an annual meeting for the public in which Title I programs will be reviewed and discussed including the parent and family engagement plan. The school will seek feedback about the current plan and make revisions based on that feedback. Additional methods of seeking feedback may include surveys. There are opportunities to provide feedback at monthly CSC meetings. Parents are welcome to contact the school principal to set up meetings and provide suggestions.

Annual Title I, Part A Meeting

Togiak School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I, Part A program, the nature of the Title I, Part A program, the parents' requirements, the school parent and family policy, the schoolwide plan, and the school-parent compact.

The annual Title I meeting will occur after school hours so that parents have the best opportunity to participate. The school will use the Remind App, social media, VHF, public postings, and flyers sent home with students to communicate school related meetings, activities, and information.
