Overview

In support of strengthening student academic achievement, **Southwest Region School District** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by Section 1116(b)(1) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended. The **Southwest Region School District** agrees to implement the following requirements as outlined in Section 1116 of the ESEA, as amended:

Joint Development

Togiak School will take the following actions to involve parents and family members in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I, Part A programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

There will be an annual meeting for the public in which Title I programs will be reviewed and discussed including the parent and family engagement plan. There are opportunities to provide feedback at monthly CSC meetings. Parents are welcome to contact the school principal to set up meetings and provide suggestions.

The annual Title I meeting will occurring in the evening so that parents have the best opportunity to participate.
